We have received many contract modifications from our members and have been reviewing them for the upcoming meetings this spring. We also have contract negotiations coming up with Contractors West and Hydro. As a Union member (IN GOOD STANDING) it gives us a voice and a vote on our working conditions and wages. Most of us have seen the slogan "United we Bargain, Divided we Beg." This is so relevant during our contract negotiations. We all need to ask our co-workers, are they paid up on their dues, have they made membership and explain to those who have not done so, that they will not have a voice or a vote on these upcoming contracts and riding on the shirt tails of those that are proactive in acquiring better work conditions and better wages is not acceptable, we all need to participate.

At the 40th IUOE General Convention last year, the theme was "Seize the Moment," this is our moment for Local 428. A new contract, a growing Union, a local with strong membership. Hello Brothers and Sisters,

Last quarter of 2023, the Department of Labor (DOL) tasked us with a Heavy and Highway wage determination survey. A survey has not been done in over ten years and Arizona will be the first state to input data under the new DOL rulings. Wage surveys are done to set the prevailing wages for different construction projects in every county. We gathered information for the past three years and went to work. Data was inputted for every project, every operators, and every piece of equipment, wages and benefits throughout the entire state. This took a lot of work to meet the deadline by January 15th and we feel confident of a positive outcome. We would like to thank all our signatory contractors who participated in this survey by providing us the information needed and to our International Representatives who came to help us put it together and submitted the data.

On November 14, 2023, we had an arbitration hearing against Encon aka Tpac for having a Company supervisor conducting work which falls under the Operating Engineers collective bargaining agreement (CBA). During the hearing, the Company made a point to criticize the Union credibility as a hiring hall and claimed we were only fighting them because we did not receive our share of Union dues. Their arguments were far from the truth, let alone their behavior under oath was difficult to endure. Needless to say, in late December, the arbitrator awarded his decision in favor of the Union. He stated the Company conducted unfair labor practices and made unilateral changes that go against the NLRB Act and our CBA. The arbitrator left it up to the Union and the Company to settle on any monetary damages. We proposed a settlement for what we believed is fair for the OE member who is currently operating the position. The Company has since gone against the arbitrator decision and denying any settlement. We will keep you informed on the result.

What you need to know

As a member of Local 428 you have options upon retirement. You can either maintain your membership or take an honorable withdrawal. Pensioner dues are \$12.00 monthly and can provide your beneficiary with a death benefit. Also, you are welcome to attend meetings, vote on current issues and upcoming elections. Your name can be retained on the out of work list for part time employment opportunities. Your membership continues to get recognition for your years of service as an Operating Engineer.

To take a withdrawal your dues need to be current through that month. The cost is \$5.00 and a form needs to be completed for your membership to be sustained. If you decide to return to the industry the card can be deposited after a period of 13 months.
